FIRST DECLARATION AMENDMENT

14

**WRITTEN CONSENT AMENDING DECLARATION
FOR COMPOUND CONDOMINIUMS**

The undersigned, who constitute a "Supermajority" of the unit owners (that is, owners having at least 75 votes) hereby adopt the following resolutions to amend, pursuant to Section 10.15, the Declaration for Compound Condominiums dated March 9, 2007, (the "Declaration"), which was recorded in the official records of Deschutes County, Oregon, on April 18, 2007, under # 2007-22303 (or at Book 2007, page 22303):

RESOLVED that Section 7.1.H(1) of the Declaration is revised by deleting the last sentence so that individual policies of casualty insurance are not required to include a waiver of subrogation rights by insurers.

RESOLVED FURTHER that Section 7.1.H.(2) of the Declaration is revised to delete the word "commercial" so that "Each unit owner also must have his own policy of general liability insurance insuring against personal injury and property damage in an amount not less than \$1,000,000 per occurrence. The board of directors can increase this minimum amount of liability insurance required of the unit owners if necessary to provide for adequate insurance coverage based upon the standards used in the community for such insurance at the time."

RESOLVED FURTHER that the secretary of the Compound Condominiums Association is authorized and directed to acknowledge this written consent on behalf of himself and the other unit owners, record in Deschutes County, Oregon, and maintain the recorded original in the books and records of the Association.
